Dear Members,

As per DGCI&S data, the Export of handloom products for the period April - November 2021 was Rs.1266.95crore / US\$170.93 million as against Rs.983.60 crore / US\$ 132.14 million for April - November 2020 registering positive growth by 28.81 in rupee terms 29.35 % in dollar terms. Though the upward trend is encouraging, handloom export is in declining trend when compared with previous 5 years. Council has initiated various measures to augment the export and submitted proposals to the ministry and organised various seminars to create awareness on handloom export.

Council has participated in India Textiles Week at World Expo 2020, Dubai, 26th November to 2nd December 2021, the world's largest business summit scheduled from 1st October 2021 to 31st March 2022, celebrates humanity's resilience, creativity, culture and innovation to create a new world in the post-pandemic era. As per the directions of Ministry of Textiles, Government of India and as a measure to promote Indian handwoven products, Handloom Export Promotion Council (HEPC) undertook sector-specific promotion activity by screening an AV film on a digital screen at India Pavilion exclusively hired by the Council. WORLD EXPO 2020, DUBAI

About Expo 2020

World Expo 2020, Dubai, the world's largest business summit scheduled from 1st October 2021 to 31st March 2022, celebrates humanity's resilience, creativity, culture and innovation to create a new world in the post-pandemic era. World Expo is organised once every five years by the Bureau des Expositions (BIS) and has been widely recognised as one of the most important platforms for the countries to showcase their achievement, capabilities, and economic prowess at the global level. The Department of Commerce, Government of India as the nodal agency to coordinate India's participation and Federation of Indian Chamber of Commerce & Industry (FICCI) as a lead Industry partner have been effectively involved in organising India Pavilion participation. The visitors from 192 countries, plus businesses, multilateral organizations and educational establishments are expected to visit this event which is being held for a period of 6 months. This is the largest event and promises to revive and rejuvenate the global economies and take businesses to a new upswing.

Field Visits at Guwahati, Assam

Day 1 – 08.12.2021

❖ Shri Sundar Murugesan, Joint Director, HEPC visited Raha Block level cluster, Nagaon, Assam and met the secretary of Block Level cluster project Lakhimi B.K.S.S Ltd under NHDP and discussed in detailed for society participation in Virtual / Physical events organised by HEPC to get into the export market.



❖ Joint Director, HEPC visited the North Eastern Development Finance Corporation Limited, NEDFi House, G.S.Road, Dispur, Guwahati which supports for the development of the entrepreneurs viz the Weavers / Master Weavers / Societies / Cluster / Handloom Producers for Handloom Export activities from North Eastern Region. NEDFi provides ranges of other services in addition to financing MSMEs. These includes mentoring of entrepreneurs in terms of setting up of unit, expansion, exposure visit, market linkage, business plan preparation, market intelligence, awareness about various schemes and policies of government, model project profiles and sectoral insights.



❖ Finally, Joint Director, HEPC visited the MD, Orient Spun Silk which is one of the intergrated manufacturing unit to produce Mulberry Silk, Muga Silk, Eri Silk, Art Silk and other Cellulosic yarn and handloom products. Recently they have added the 20 Jacquard handlooms. The Mulberry, Muga, Eri, Art yarn will be used in making of Saree, Mekhala Chaddar, Punjabi Kurta and Made-up items in house production to make value added handloom products. Council official had explained the activities of HEPC and they confirmed to take the HEPC membership for participation in international events.



Day 2 – 09.12.2021

❖ Executive Director and Joint Director, HEPC visited Handloom Park at Musalpur, Assam and manager BRAWFED (Bodoland Regional Apex Weavers & Artisans Co-Operative Federation), BTC, Kokrajhar, Assam. Council officials had meeting with MD & officials of BRAWFED. MD BRAWFED requested HEPC to identify the suitable Joint Venture partner for manufacturing Eri's Spun Silk, Yarn unit inside the park for which the land is readily available. BRAWFED requested HEPC to approach ministry for partnering Joint Venture with NEHHDC, which is subsidiary organisation under DoNER ministry for signing MOU's with Govt. of India and they are also ready for Joint Venture for Spun, yarn manufacturing in the Park. Finally, both the organisation request HEPC to formulate the suitable scheme for spun and Yarn inside the park for exclusive export market for their value-added handloom items made out of raw materials spun out from this unit. The Handloom Park at Musalpur, Assam had more than 25 sheds.

Harmonized System (HS) nomenclature, HS-2022

The new (seventh) edition of the Harmonized System (HS) nomenclature, HS-2022 has been introduced to be effective from 1st January, 2022 covering a wide range of goods moving across borders. The gazette notification of Ministry of Finance Act 2021 having reclassified the HS Code and the abstract of correlation between HS 2021 and HS 2022 issued by the CBIC is in the following link. Seminar at Guwahati, Assam

The One-day seminar with more than 60 participants comprising Weavers, Master Weavers, Co-op societies, Producers company & exporters from North eastern region. Shri Sundar Murugesan, Joint Director, HEPC welcomed the participants with his speech to the gatherings about the objectives of the seminar. Shri N. Sreedhar, ED HEPC delivered the Keynote / welcome address to participants of the seminar. In his speech he explained the HEPC's efforts and supports to help the exporters from the North-Eastern region.

S.Das, AD (P), WSC, Guwahati also delivered a speech on exportable handloom items from the Assam. He mentioned in his speech that the states handloom products are already going to the ASEAN countries like BHUTAN, MYANMAR etc. in an unorganized manner. He also assured the attendees of the seminar to help in the technical or training part of the handlooms from WSC, Guwahati. Both the guests delivered the speech about the boosting of Handloom Export from NE region and thanked HEPC for organizing such kind of seminar at their place, and also for encouraging the people of Handloom Sector.



Shri Sundar Murugesan, JD, HEPC gave a presentation on the activities of the HEPC. He had thoroughly explained the HEPC's workings, fair participation, membership categories and

procedures and also briefed about the market potentiality of handloom products from the NE region. He interacted with attendees and answered all the questions raised by them. Mr. P. Vasu, Director, IIHT Guwahati gave a presentation about the Indian Institute of Handloom Technology, Guwahati. In his presentation he explained about the courses offered by the Institute, about the MOU signed with the reputed stakeholders of the handloom sector from the NE, region. He also showed the various technological interventions/modifications done by IIHT, Guwahati on handlooms and also asked the stakeholders to utilize the same in terms of more upgraded handloom production. Shri TC Deka, FTDO, Jt DGFT Guwahati gave presentation about Pre requisite for starting an export Business. He briefed about the IEC related issues and explained the new contactless working of DGFT provided to the exporters. Shri. Jayanta Thakuria, TS (Weaving), WSC, Guwahati gave a power point presentation on India Handloom Brand and Handloom Mark. In his presentation, Mr. Thakuria explained each and every step to be followed for obtaining the India handloom brand tag and Handloom Mark. He also interacted with the gathering on their issued for obtaining the IHB, handloom mark and also assured every possible help to the stakeholders for the same.

Shri M. Islam, Sr Officer, NHDC, RO Guwahati gave a presentation on NHDC's revised raw materials supply scheme. In his power point presentation, Mr. Islam briefed about the eligibility criteria's, yarn passbook. quantity of the raw materials, transport subsidies etc to the gatherings. He also informed that NHDC, s revised scheme now covered the handloom entrepreneurs, which was not in the earlier scheme. He had interacted with the stakeholders and answered the questions raised by them. In the seminar, Mr. Heeralal Kalita, Proprietor, Haramohan Silk Factory, Sualkuchi displayed diversified Muga Silk handloom product. Mrs Pkumoni Das, Partner of Marvella Associates, Guwahati displayed Mulberry silks exportable handloom products. Mrs Namita Abong, Proprietor, M/s Jayashree, Guwahati displayed natural dyed Eri Silks products. The dignitaries/guests/ gatherings had interacted with them and also encouraged their high-quality handloom products. Further, success stories have been shared by M/s. AVA creations, Guwahati from Zero to Rs. 2 Cr business which will be a motivating factor to all the participants of the Seminar. Also, M/s. RENA Handlooms, Manipur & M/s. Madhusree managed by Ms. Jain, who has developed the Muga silk combination of Eri Silk and she conveyed that the saree of his own production has sale value of Rs.30000/- each. Also, she confirmed her participation in Council's overseas events.

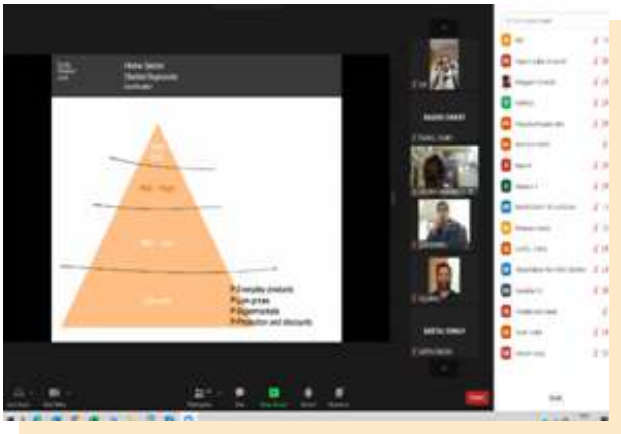

Virtual webinar on 'Your opportunities in the European Market'

EU market is an important market for the product group of our member exporters since there are 7 countries in European region among top 10 importing countries of Indian handwoven products. Hence, an understanding on consumer behaviour, product trends and style preferences in the market is essential for manufacturers / exporters to tap the market potential opportunities. As a measure to provide inputs on above parameters, HEPC has availed the services of Ms. Irene Vermeulen, a design and marketing consultant and founder of Craftscurator.com to host a live interactive workshop titled '**Your opportunities in the European Market' on Thursday December 16, 2021.**



The webinar event started with a welcome address by Shri.N.Sreedhar, Executive Director and was followed by a presentation from Ms. Irene on the following topics.

- Explore the most important product categories.
- Understand the main market segments.
- Select a style group to research.
- Discuss the most promising consumer trends.
- Express the needs of your company.

Over 25 member exporters from the states Assam, Bihar, Haryana, Kerala, Maharashtra, Punjab, Tamil Nadu & Uttar Pradesh, participated in the live workshop Webinar and handouts were provided to all the participants. All the participants expressed their satisfaction on the initiative of HEPC to organise such a webinar, which they felt was really useful. During the workshop, several surveys were

conducted with an active participation from the participants and the details of the same is furnished below.

Poll 1- Product Segment

79% of the participants confirmed that they would export Home Accessories / Cushions and Throws product group to Europe. Followed by Kitchen linen, Bed linen and Rugs / Carpets.

Poll 2- Market Segment

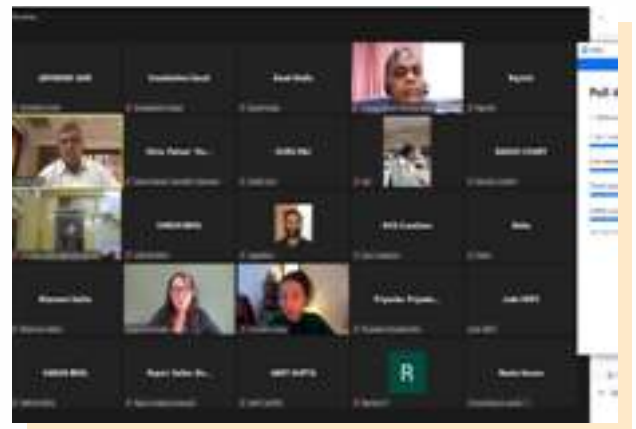
The survey revealed that 83% of the participants target Mid/High-end market in Europe, followed by Mid-low Segment (11%) and High-End segment (6%).

Poll 3- Strategy to strengthen market position

45% of the participants informed that they would like to strengthen their market position using consumer trends and focusing target market segments. 30% informed that they would like to strengthen their market position by marketing successful product ranges by developing their own design signature. 15% through Identifying Product Trends, and Materials, Techniques, Patterns and Colour myself and the remaining 10% by way of Creating effective materials for online promotion and hybrid trade fair participation

Seminar at Panipat

Handloom Export Promotion Council (HEPC) has organized a Seminar on 28.12.2021 at Hotel Gold, G.T.Road, Panipat on DGFT-Export Facilitation, Colour Trends and GST on Exports to create awareness among the Master weavers, Exporters, aspirant exporters & Co-operative Societies about export procedure, facilities and assistance available from various departments of Government of India, for the benefit of all the concerned in Panipat and nearby areas. The seminar has been organized with financial assistance of O/o. the Development Commissioner for Handlooms, Ministry of Textiles, Government of India under NHDP scheme. The Seminar was Co-chaired by Shri N.Sreedhar, Executive Director, HEPC, Shri Vishal Sharma, Dy.DGFT, Panipat and Executive Committee members Shri Lalit Goel, Shri Ramesh Verma and Shri Ashok Gupta.

The Seminar began with welcome address by Shri N.Sreedhar, Executive Director, HEPC. In his welcome address the Executive Director assured to extend full support of the Council to trade. All the speakers and Executive Committee members were felicitated with a bouquet. About 55 exporters / aspirant exporters and weavers have participated in the Seminar. Shri Ramesh Verma, EC member, HEPC has addressed the gathering and appreciated HEPC's effort to sensitize the Handloom Entrepreneurs in Panipat. He also urged them to get associated with HEPC to avail more benefits. In his special address Shri Ashok Gupta, EC member HEPC stated with government support and hard work of entrepreneurs, Panipat is now well known as a manufacturing hub for floor coverings and Carpets around the globe.

The technical session started with power-point presentation by Mrs.Savita Rana, Professor, NIFT, Delhi on "Color Trends and Visual Merchandising". In her presentation, she has briefed about the trends, colour forecasts, Importance of color in Fashion. She has also briefed about the importance

of Visual Merchandising through various pictures. Shri Pradeep Tayal, Chartered Accountant & Mrs.Suman Bansal jointly made a power point presentation on Goods and Service Tax (GST) on exports. They explained concepts of GST on exports, Freight on Import, Interest on net tax liability etc. During the presentation they have also answered various queries raised by audience and discussed do's and don'ts in GSTR.

Shri Vishal Sharma, Dy.DGFT, Panipat has described about highlights of Foreign Trade Policy 2015-20 & its documentation, Importer-Exporter code number documentation, Export Promotion Schemes such as Duty exemption, Duty neutralization/remissions, rewards/incentives, Advance Authorization Schemes etc. Shri Kapil Mittal, Jt.Director, District Industries Centre, Panipat has described about MSME schemes available for MSMEs and the benefit of Government to various sectors of MSME. Shri Sanjay Kumar, Branch Manager, ECGC, Panipat gave power-point presentation on services of ECGC.

Shri M.Sundar, Jt.Director, HEPC has made power point presentation on export benefits. He has also briefed about the Export Trends, Council's activities & Procedure to obtain membership of the Council and its benefits to members. He also requested the entrepreneurs to come forward to participate in events organized by HEPC to explore the export market and avail the benefits with HEPC registration.

Recommendations of 46th GST Council Meeting

Existing GST rates in textile sector to continue beyond 1st January, 2022

The GST Council's 46th meeting was held today in New Delhi under the chairmanship of Union Finance & Corporate Affairs Minister Smt. Nirmala Sitharaman.

The GST Council has recommended to defer the decision to change the rates in textiles recommended in the 45th GST Council meeting. Consequently, the existing GST rates in textile sector would continue beyond 1st January, 2022.

International Textile Certification - GOTS

The Global Organic Textile Standard (GOTS)- A brief

The Global Organic Textile Standard (GOTS) is the worldwide leading textile processing standard for organic fibres, including ecological and social criteria, backed up by independent certification for the entire textile supply chain.

GOTS covers the entire post-harvest processing (including spinning, knitting, weaving, dyeing and manufacturing) of apparel and home textiles made with certified organic fibre (such as organic cotton and organic wool), and includes both environmental and social criteria. Key provisions include a ban on the use of genetically modified organisms (GMOs), highly hazardous chemicals (such as azo dyes and formaldehyde), and child labour, while requiring strong social compliance management systems and strict waste-water treatment practices.

GOTS was developed by leading international standard setters - Organic Trade Association (U.S.), Japan Organic Cotton Association, International Association Natural Textile Industry (Germany), and Soil Association (UK) to define globally recognised requirements that ensure the organic status of textiles, from field to finished product. GOTS is a non-profit organisation which is self-financed. For more information please visit our website: www.global.standard.org.

Textile Exchange's 2021 Organic Cotton Market Report showed that 2019/20 was a record-setting year, with the largest volume of organic cotton fibre harvested globally to-date. In total, 229,280 farmers grew 249,153 tonnes of organic cotton fibre on 588,425 hectares of certified organic land in 21 countries. This represents a four percent growth in fibre volume and is the fourth year in a row that organic cotton production has increased. Organic cotton accounted for almost one percent of the global cotton harvest that season. Ranked by production, the top seven organic cotton-producing countries, which together account for 95 percent of global production, were India (50%), China (12%), Kyrgyzstan (12%), Turkey (10%), Tanzania (5%), Tajikistan (4%), and the U.S. (3%).

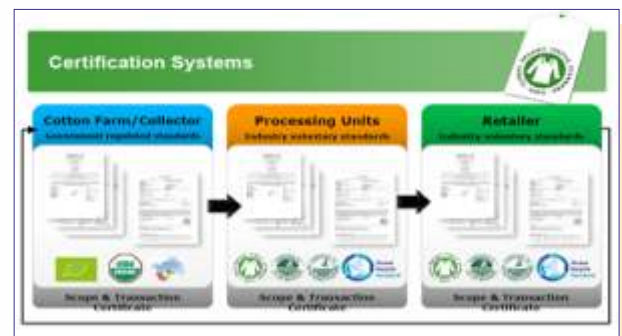

GOTS Certification system

The GOTS certification system covers the entire supply chain from farming (cotton cultivation) to packing of end products.



Every processing and manufacturing stage of finished goods should possess transaction certificate for traceability & identification of compliance of GOTS requirement.

Technical quality parameters

Any final product labeled according to organic GOTS Standard shall comply with the following technical quality parameters.

SPECIFIC REQUIREMENTS AND TEST PARAMETERS

Separation and Identification

All stages through the supply chain shall be established so as to ensure that organic and conventional fibres are not commingled and that organic fibres and GOTS Goods are not contaminated by contact with prohibited substances. All organic raw materials and GOTS goods shall be clearly labelled and identified as such at all stages of the supply chain.

Spinning

The inputs material should be approved by the GOTS and the list prohibited and restricted inputs and the requirements related to hazards and toxicity are separately listed in the GOTS. Any paraffin products used shall be fully refined with a limited value for residual oil of 0.5%. Machine oils that may come in contact with GOTS goods shall be heavy metal-free. Synthetic fibres, which are to be

dissolved at a later processing stage, are not allowed to be used.

Sizing and weaving / knitting

Allowed sizing agents include starch, starch derivatives, other natural substances and CMC (carboxymethylcellulose).

Synthetic sizes which meet the basic requirements in GOTS may be used for no more than 25% of the total sizing in combination with natural substances only, calculated for the chemical without water. In case such synthetic sizes are recycled/recovered in the wastewater from desizing process with a ratio >80% they may be used without limitation in the total sizing but shall still meet the requirements as per GOTS requirement.

Machine oils that may come in contact with GOTS goods shall be heavy metal-free. Other inputs shall be derived from natural materials only.

Pre-treatment and other wet processing stages

Any process of mechanical wet is allowed. However, Chemical wet must be GOTS approval.

Environmental management

In addition to GOTS criteria, all companies shall assure compliance with the applicable national and local legal environmental requirements applicable to their processing/manufacturing stages (including those referring to emissions to air, wastewater discharge as well as disposal of waste and sludge). Adequate inventory of GOTS approved chemical inputs should be maintained for processing GOTS Goods. Wet processing units shall keep full records of the use of chemicals, energy, water consumption and wastewater treatment, including the disposal of sludge.

Social Criteria

The Standard sets requirements concerning working and social conditions that are equivalent to those of leading social sustainability standards. Some of the sections from social criteria under GOTS version 6.0 are highlighted here.

- Child labour shall not be used
- No discrimination is practised
- Occupational health and safety (OHS)
- No harassment and violence
- Remuneration and assessment of living wage gap

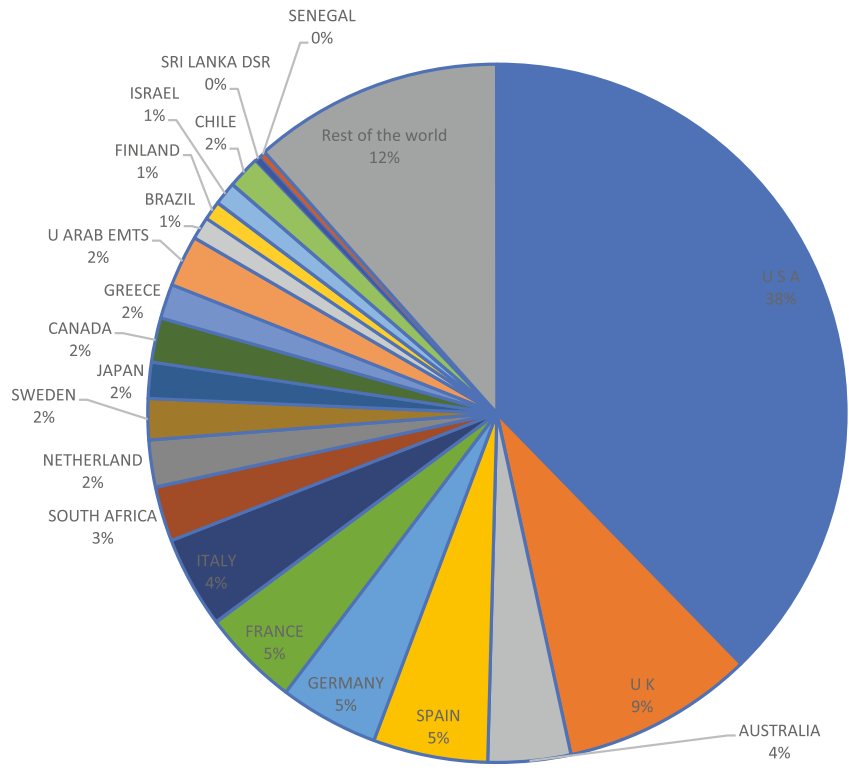

Handloom Export Share in % 2021-22 (Projected) Country Wise

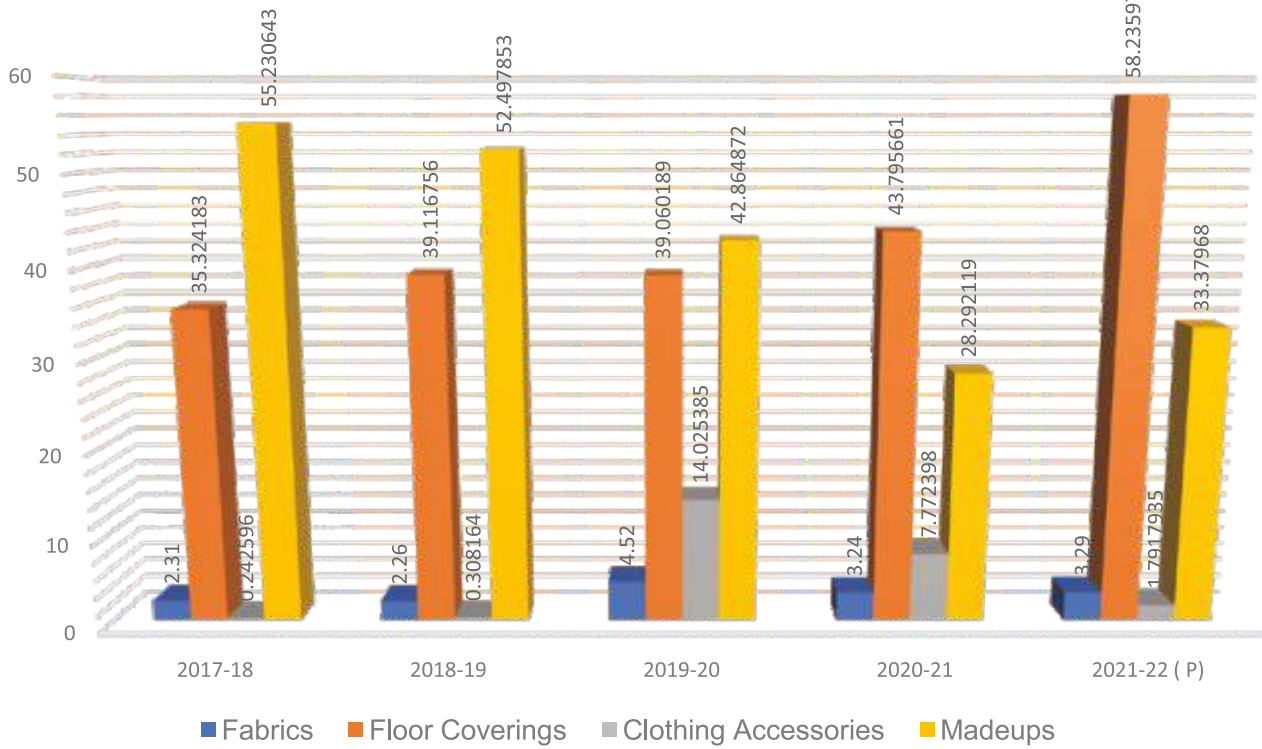
