*Dear Members,*

COVID-19 has led to a fall in global exports and the suspension of many businesses and production units across the world and has caused a shift in consumer behaviour. As a handful of consumer new shopping habits are likely to stay in the long term when the pandemic ends and a new normal begins, online shopping will increasingly become a prominent buying channel for consumers going forward.

The US and the European Union are the two largest markets for Indian textile exporters. With all the export promotion & development planning it is expected to grow to US\$2,600 billion by 2025. However, the pandemic of COVID-19 has affected all over the world economy. The Indian Textile Industry has hard hit by the Covid-19 in the first quarter of the year.

As per the provisional export data received from DGCIS, export of handloom products for the period April - June 2020 was Rs.187.84 crore/US\$ 24.80 million as against Rs.635.41 crore/US\$ 91.34 million over the corresponding period of last year April 2019 - June 2019 witnessed negative growth by 70.44% in rupee terms and 72.85% in dollar terms.

Since the pandemic is still unfolding, the economic impact may be even more severe in emerging markets in the coming period. According to the IMF's latest June World Economic Outlook update projects emerging market economies to shrink by 3.2 percent this year. There are many forecasts on post COVID international trade across the globe but the recent news of Japan's Ministry of Economy and Trade and Industry has added India and Bangladesh to the list of relocation destinations for companies which shift their manufacturing sites from China to ASEAN countries is promising.

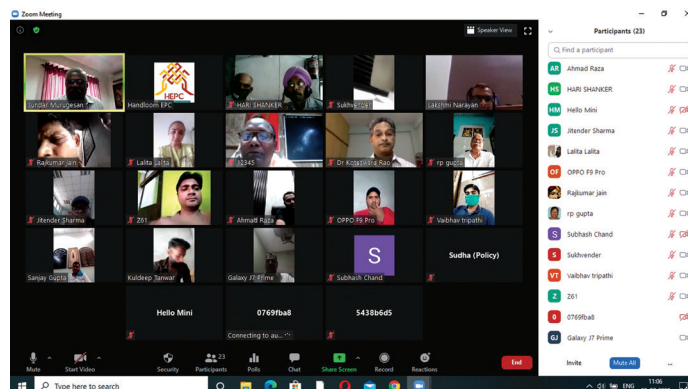
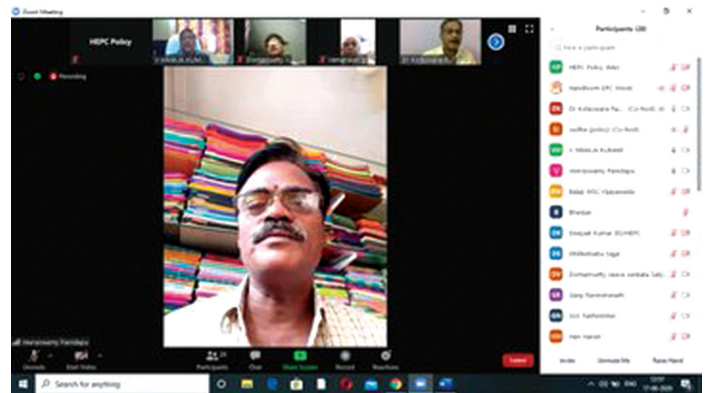
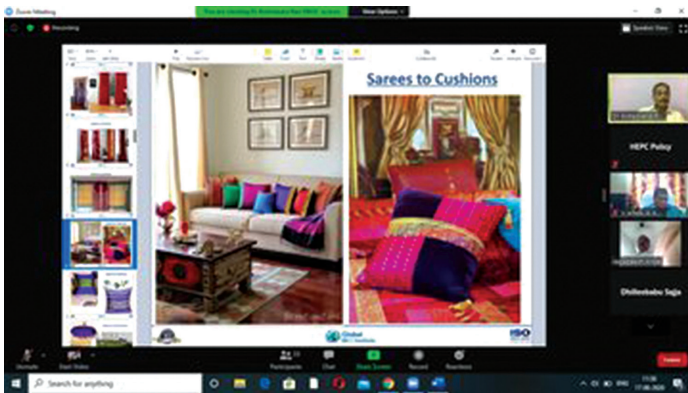
## WEBINARS

The COVID-19 pandemic situation has severely impacted the world economies across the globe and industrial production across various sectors are either under temporary suspension or in slow down phase and India Textile industry is in no exception to this.

In this new normal situation, life versus livelihood has become a debatable point and there is a need to strike a balance and focus on reviving economic activities. With the lockdown are getting relaxed in phased manner, industry is limping back to normalcy.

In this challenging environment, Exporters are finding new strategies through product innovation, adapting innovative marketing strategies to reach out to buying community. The role of Buying agents in the country is assuming a significant importance in promoting the export trade from our country.

In this industrial scenario, HEPC in association with Federation of Buying Agents (FBA) is planning to organise series of Vendor connect Programme in the coming days so as to provide a platform for the manufacturers to get connected with Buying agents and their overseas counterpart. As a prelude to the Vendor Connect Programme, a virtual Introductory session was organised on 26<sup>th</sup> July 2020 from 7.00 pm to 8.30 pm

Mr. T.V. Chandrasekaran, Chairman, HEPC delivered the opening remarks and also made a presentation on handloom industry, the activities of HEPC and strategies for the days ahead, which was followed by a speech and presentation on FBA by Mr. Lokesh Parashar, President Federation of buying Agents. The discussion on the benefit for participating in the Vendor Connect Programme was found to be informative. Interaction was held on various issues confronting the industry in this unprecedented current scenario and also possible area of cooperation between HEPC & FBA in promoting export trade for Indian handwoven products. Dr. Deepak Kumar, IAS., Executive Director, HEPC, and Ms. Sandhya Samuel, Vice President, Federation of Buying Agent made the closing remarks. The introductory Vendor Connect Programme was attended by over 30 participants on the virtual platform and many others on live on facebook.



### CHINA GRANTS TARIFF EXEMPTION FOR 97% OF BANGLADESHI IMPORTS

China has granted zero-duty treatment for 97% of the tariff lines originated from Bangladesh effective 1 July, announced Customs Tariff Commission of China's State Council on 16 June. With this policy, a total of 8,256 tariff lines imported from Bangladesh are exempted from tariffs, including the 3,095 tariff lines that are already enjoying duty-free access to China under the AsiaPacific Trade Agreement (APTA) and an additional 5,161 tariff lines. The announcement came one month after Bangladeshi Prime Minister Sheikh Hasina and Chinese President Xi Jinping held a discussion to upgrade their bilateral relations during the COVID19 pandemic. The tariff concession is part of China's commitment to offer duty-free, quota-free access to the least developed countries (LDCs) that have established diplomatic relations with China.

### JAPAN TO OFFER INCENTIVES TO COMPANIES SHIFTING BASE FROM CHINA TO INDIA

Japan's Ministry of Economy, Trade and Industry (METI) has added India and Bangladesh to the list of relocation destinations for companies which shift their manufacturing sites from China to ASEAN countries. By expanding the scope of the subsidy programme, Japan aims to reduce its dependence on a particular region and to build a system which is able to provide a stable supply of medical materials and electronic components even in an emergency. The government has allocated 23.5 billion yen in 2020 supplemental budget for the subsidy to encourage companies to disperse their manufacturing sites across ASEAN region.
