Other terms of participation as specified in our earlier circular dated 3-10-2022 remains unchanged and the same is again given below.

#### **Product Categories:**

- 1. Table Linen: Table cloths, napkins, placemats and table runners.
- 2. Kitchen Linen: Aprons, gloves, mittens and tea cosy, dish towels, tea towels, etc.
- 3. Bed Linen: bedspreads, Pillow cases, duvet covers, Bed Sheets, etc.
- 4. Furnishing Articles: Cushions, bolsters, throws, etc.
- 5. Curtains: Curtains of all types, voile curtains, drapes and Window Blinds.
- 6. Toilet linens: Hand towels, bath towels, both terry and non-terry products.
- 7. Floor coverings such as door mat, bathmat, rugs, carpets etc
- 8. Fabrics: fabrics, plain, jacquard of various constructions including furnishing fabrics like upholstery, curtains, etc.
- 9. Clothing Accessories Stoles, scarves and shawls

#### Travel Grant eligibility details: (upto Rs.1,25,000 as per the conditions given below)

Member participants are entitled for participation under subsidized category availing grant only up to a maximum of three participations in a particular trade fair (including past cases). In case of exporters belonging to SC/ST/Women and the exporters having f.o.b value of exports of or less than Rs.50 crore in a year, 5 participation in a particular event is allowed.

Maximum of three MAI events in a year (April-March) is allowed for each member participant including participation through other EPCs. Maximum of five MAI events in a year (April-March) is allowed in case of exporters belonging to SC/ST/Women and the exporters having f.o.b value of exports of or less than Rs.50 crore in the preceding year, provided each one of these is in different market (E.g. Africa, LAC, WANA, ASEAN etc.)

Further, the participants who had completed 12 months of membership with the council and having exports of FOB Value up to Rs.50 crore in preceding financial year will be entitled for a travel grant reimbursement for the travel of Regular director/Partner/Proprietor of the company or a regular officer of the company on senior managerial position (not admissible to a foreign national) **up to Rs.1,25,000/- (economy class air travel) or actual (whichever is less)** or lump sum amount whichever is to be approved by Ministry.
